Notice is hereby given that sealed bids will be received at the White Bear Lake City Hall, 4701 Highway 61, White Bear Lake, Minnesota 55110, until 11:00 a.m. on Wednesday, March 25, 2020 at which time they will be publicly opened and read aloud by the City Engineer and Engineering Secretary, said bids to be for the furnishing of all labor and materials to complete the following described local improvements under Minnesota Statutes, Chapter 429:

Street reconstruction on: Cottage Park Road (Lakeview Avenue to Old White Bear Avenue), Circle Drive (Cottage Park Road to Cottage Park Road), Lakeview Avenue (South Shore Boulevard to Old White Bear Avenue), and Bellaire Avenue (Orchard Lane to County Road E)

All bids should be made on the proposal form provided for that purpose and according to the contract documents prepared by the City Engineer, 4701 Highway 61, White Bear Lake, MN, and dated March, 2020.

Plans, specifications, bid forms and contract documents are available at the office of the City Engineer, 4701 Highway 61, White Bear Lake, Minnesota 55110. Contractors desiring a copy of the above documents may obtain them from the office of the City Engineer upon payment of a deposit

of \$75.00, which is non-refundable. An electronic version of plans and specifications may be obtained through QUEST CDN at www.questcdn.com – Project No. 6863543 for a fee of \$15.00.

Each bid shall be accompanied by a bidder's bond naming the City of White Bear Lake as obligee, cashiers' or certified check made payable to the City of White Bear Lake or a cash deposit equal to at least 5% of the amount of the bid, which shall be forfeited to the City in the event that the bidder fails to enter into a contract.

Bids should be directed to the City Engineer at 4701 Highway 61, White Bear Lake, MN 55110, securely sealed and endorsed upon the outside wrapper with a brief statement or summary as to the work for which the bid is made, labeled, "2020 Street Reconstruction Project - City Project Nos. 20-01 and 20-06".

The City Council reserves the right to reject any and all bids, to waive irregularities and informalities therein, and to award the contract in the best interest of the City. Bids arriving after the designated time will be returned unopened. No bidder may withdraw his bid within sixty (60) days after the scheduled closing time for the receipt of bids.

Immediately following expiration for the time for receiving bids, the City Engineer and the City Clerk will open the bids at the White Bear Lake City Hall office, 4701 Highway 61, White Bear Lake, Minnesota. The City Council will consider such bids in the Council Chambers at its regular scheduled City Council meeting held at 7:00 p.m. on Tuesday, April 14, 2020.
