**SUBJECT:** Multi-Jurisdictional Recycling Support - PEIG Final Report

#### **Background**

In December 2014, the City of White Bear Lake was awarded a Ramsey County Public Entity Innovation Grant in the amount of \$52,299 to partially fund a position that would provide multijurisdictional communication, outreach and multi-unit recycling support for White Bear Township and the Cities of Little Canada, Vadnais Heights, and White Bear Lake. This grant provided assistance in meeting the following objectives:

Objective 1. Expand or enhance services for education and outreach regarding City recycling programs and County core messages.

Objective 2. Expand or enhance services for multi-unit recycling, including improvements in the collection of recyclable materials at multi-unit dwellings, expanded outreach and technical assistance.

Objective 3. Develop a partnership among the cities involved to provide expanded recycling outreach.

The original grant period extended from December 1, 2014 through January 31, 2016; however, the project was put on hold in February 2015 when the project lead left the position for another opportunity. The project resumed in June 2015 when a new staff person was hired. The project scope was expanded in December 2015 to include the City of North St. Paul, increasing the budget to \$59,177 and extending the grant period through June 2016.

#### Key individuals

The City of White Bear Lake housed a temporary staff person to serve as the project lead. White Bear Township and the Cities of Little Canada, North St. Paul, and Vadnais Heights worked with the City of White Bear Lake to provide necessary data and direction to complete the project's goals within their communities.

#### **Project Results**

Objective 1: Expand or enhance services for education and outreach regarding City recycling programs and County core messages.

During the first three months of the project, the primary focus was to work with the communities to update respective websites and assist with general communication efforts. The project lead worked with staff at Little Canada, Vadnais Heights, White Bear Lake, and White Bear Township to review each community's recycling communication plans and assess current communication efforts. The following tasks were completed:

- Reviewed and updated the trash and recycling web pages for Vadnais Heights, White Bear Lake and White Bear Township.
- Reviewed the trash and recycling web pages for Little Canada and provided comments to City staff.
- Created a Refuse and Recycling Residential Guide and Going Green Guide for White Bear Township.
- Created a hauler report for the City of Vadnais Heights.

The websites were periodically reviewed and updated throughout the grant period.

Objective 2: Expand or enhance services for multi-unit recycling, including improvements in the collection of recyclable materials at multi-unit dwellings, expanded outreach and technical assistance.

Work was done at the beginning of the project to identify all multi-unit complexes in each community. Multi-unit recycling is defined in City Code and varies from community to community. Dwellings that meet the definition of a multi-unit are not typically in the community's recycling contract; however, North St. Paul allows multi-unit properties to opt-in to their contracted garbage and recycling collection service. A few properties fall outside the multi-unit definition but are not on the City contract. Two of these properties were identified during the site visits and include a duplex at 2568-70 Ruth Street in Little Canada and Birch Lake Townhomes in White Bear Lake.

#### **Multi-unit Definitions**

- *Little Canada*. Multi-family Dwelling Unit: defined as a structure or portion thereof, designated or used predominately for residential occupancy of a continued nature, including tri-plex, four-plex, townhome, condominium, apartment, and mobile home dwellings.
- *North St. Paul.* Dwelling, Multi-unit Housing: defined as a building or complex which provides more than four residential dwelling units with a kitchen or area for food preparation as part of a large building or complex, and which as part of the rental fee or association dues, provides refuse service for the entire group of households with dumpster service.
- *Vadnais Heights*. Multiple family dwellings: defined as a building or a portion thereof containing nine or more dwelling units.
- White Bear Lake. Multi-Family Dwelling Unit: defined as a building or complex which provides more than four (4) residential dwelling units with a kitchen or area for preparation of food as part of a large building or complex which, as part of the rental fee or association dues, provides refuse service for the entire group of households with large vat type containers.
- White Bear Township. Multiple Family Dwelling: defined as a dwelling or a portion thereof containing three or more dwelling units.

It was originally thought that to determine a baseline and evaluate success of the project, a pilot study was to be performed at two buildings in each community. At a meeting in June 2015 with Ramsey County and White Bear Lake staff, it was decided that a more efficient and effective approach would be to conduct site visits and provide education and outreach to all multi-units within each community.

#### Site Visits

In mid-June 2015, the project lead began conducting site visits to document the recycling infrastructure at 128 multi-unit properties: 43 in Little Canada, 37 in North St. Paul, 9 in Vadnais Heights, 38 in White Bear Lake, and 1 in White Bear Township. To streamline the process and to ensure that consistent information was gathered, a site visit checklist template was used during each site visit (Exhibit 1). The general results of the site visits are described below. The detailed site observations for each property are documented in the spreadsheet in Exhibit 2. The properties are organized in the spreadsheet by community, then by the number of units from smallest to largest.

- Hauler. The hauler for each property was determined from the company labels on the trash and recycling containers during the site visit. A total of nine haulers were identified: Ace, Advanced, Aspen, Genes, Nitti, Republic, Trojes, Walters, and Waste Management. The hauler is unknown at two properties in Little Canada and four in North St. Paul. Exhibit 3 shows the location of the multi-unit properties and their haulers.
- Number and types of recycling containers. The number and types of recycling containers were recorded on the site visit checklist for each property. Many of the townhomes and properties with 4 units or less use recycling carts, while larger apartment buildings tend to utilize dumpsters. For apartment buildings with recycling carts, the number of units per cart ranges from 3 to 37.8. The number of units per cart for these properties is identified in column 6 of Exhibit 2, and two examples are shown in Exhibit 4. Eleven properties in Little Canada and four in White Bear Lake do not have recycling service.
- Location of recycling and trash. For properties with outdoor trash and recycling containers, the project lead documented the location of the recycling containers relative to the trash containers and whether or not the recycling containers are easily accessible to tenants. For properties with enclosures, some are adequately sized to accommodate both trash and recycling containers, while others can only accommodate one or the other. Exhibit 5 shows examples of some of the trash and recycling container configurations.
- Type and condition of recycling labels. The project lead documented the location, condition, and type of labels on the recycling carts and/or dumpsters, noting if the labels contained lists of allowable recyclables, images, or both. Inconsistent messages and/or poor quality labels were common problems encountered in all five communities. Many of the labels were difficult to read because of small font size. Images were small and difficult to decipher, and some of the labels were not in the proper location or were peeling, faded or missing. Exhibit 6 shows examples of some of the labels encountered.
- Type of contamination in recycling. The project lead documented the non-recyclable items that were easily identified in the recycling dumpsters/carts without digging through the contents. The most common items found include plastic bags (shopping bags, bubble wrap, and plastic bottle/paper towel/toilet paper wrap), Styrofoam, frozen food boxes, textiles, bags of trash, coffee cups, and other miscellaneous non-recyclable plastic items such as toys and laundry baskets. Senior living centers generally had the least amount of contamination in their recycling. Exhibit 7 shows examples of some of the contaminants encountered.
- Type of recycling in trash. The project lead documented the recyclable items that were visible
  in the trash dumpsters/carts. The most common recyclable items found include cardboard,
  metal cans, plastic bottles, glass bottles, and newspaper. Exhibit 8 shows examples of some of
  the recycling found in trash containers.

#### **Education and Outreach**

Sixty-four in-person interviews were conducted with on-site property managers, caretakers, and/or maintenance personnel. The most effective method of reaching out to property contacts was to stop by the manager's office unannounced during the initial site visit. Using this approach, only three out of sixty-seven on-site managers were not interested in being interviewed. Contacting managers by phone was the least effective method and did not result in any interviews.

A survey question template was created with input from Ramsey County. This template was used during interviews with property managers (Exhibit 9). The most common answers to the interview questions are described below, and all responses are documented in Exhibit 10, which is organized by community, then by the number of units from smallest to largest.

Does your building have trash chutes? Nineteen of the sixty-four building personnel interviewed manage properties with trash chutes (Table 1). In these buildings, a recycling dumpster is typically located in the basement parking area for residents to use. If space allows, recycling bins are sometimes provided in the trash chute rooms. Most of the managers allowed photos to be taken of their trash chute rooms and recycling areas, a few of which are shown in Exhibit 11.

- Have you encountered any problems? The most common problems identified were contamination in the recycling and recycling in the trash. For properties where the trash is more convenient than recycling (i.e. trash dumpsters outside of an enclosure; trash chute rooms, etc.) managers were more likely to observe larger amounts of recycling in the trash dumpsters. If the recycling dumpster was more convenient, the managers encountered more trash in the recycling. Other problems identified by the managers included the lack of space for recycling containers, language barriers, lack of education, high tenant turnover, and illegal dumping.
- What are your methods of communication with residents? Common methods of communication in multi-unit buildings include new tenant handbooks, welcome letters, new tenant tours, bulletin boards, newsletters, meetings, and special events. A few apartments installed signs in trash chute rooms and basement recycling locations in response to specific contamination problems. The signs included messages about what to recycle and what not to recycle. See Exhibit 12 for examples.
- Would you like educational materials? The project lead offered free Ramsey County multiunit educational materials at the time of the interview. Many of the managers do not have time to create their own educational materials so they were happy to have these resources available to them. Table 2 summarizes the educational materials given to building managers in each community. The door hangers were mainly used on bulletin boards or as an insert in new tenant packets. The large posters were hung over recycling dumpsters or in trash chute rooms. See Exhibit 13 for photos of educational materials.

- Are you willing to be on an email list? Managers were asked if they would be willing to be on an email list to receive periodic updates about recycling. Two of the managers did not have an email address, all of the others agreed to be on the list. One challenge is to maintain long term contact with building managers due to frequent staff turnover. Emails may provide the most efficient and effective way to keep in touch long term since many of the emails are tied to the property, not to individual managers.
- Are there recycling containers in other areas of your building? If not, would you be interested if we provided them? Most managers were not interested in using recycling bins in common areas due to appearance and concerns of tenants using the bins for trash.
- Do you require recycling as part of your lease? None of the properties require recycling as part of a lease.
- Do you educate your tenants on what to do with unwanted items? Each property manages the disposal of unwanted items differently, and there is a general lack of education in this area. Some properties provide containers for residents to dispose of batteries, fluorescent bulbs, and paint (Exhibit 14).

#### Summary of Problems Encountered and Recommendations for Improvement

Below is a summary of the most common problems encountered during the site visits and interviews, followed by a brief paragraph discussing recommendations for improvement. A summary of these problems is also outlined in Exhibit 15. Each partner community, along with guidance from the County, can use the information gathered from this project to identify and prioritize their own specific multi-unit recycling issues and solutions that best fit their needs and objectives.

#### Level of Service

Findings: As discussed above, for the larger multi-unit properties that use recycling carts, the number of units per cart ranges from 3 to 37.8. In addition to the large number of units per cart, the recycling collection frequency may need to be evaluated. For example, the manager of White Bear Royal Apartments in White Bear Lake cited problems with the recycling carts frequently overflowing and as a result, tenants place recycling on the ground. There are only eight recycling carts for 80 units (10 units per cart) at this property, with a recycling collection frequency of only once per month.

Recommendations for improvement: The three of the partner communities include general container number and volume requirements and/or collection frequency requirements in their ordinances. Ideally, these ordinances should be enforced. Ordinances could be updated to require a more specific recycling capacity, such as a 1:1 trash to recycling volume for example.

#### **Ordinances**

- Little Canada. Collection required: every property owner or occupant of a place of business or multi-family dwelling unit, that accumulates mixed municipal solid waste and recyclables, shall provide for collection as defined in Minnesota Statutes, Section 115A.941 regarding required collection. This collection shall be at the person's own expense and shall be at least once a week or at such other times as the City may determine necessary to protect the health and safety of the residents of the City.

Containers: Every property owner and occupant of any dwelling unit, including single family homes, duplexes, tri-plexes, four-plexes, mobile homes, town houses, condominiums and apartment buildings, shall provide a sufficient number of containers...which do not exceed ninety (90) gallons capacity. An exception to this provision would be possible in the case of multi-family dwelling units where an alternative refuse management plan is submitted to and accepted by the City.

- Vadnais Heights. Required recycling services; multiple family dwellings. Collection services required: the owner of a multiple family dwelling shall make available to the occupants of all dwelling units on the premise services for the collection of designated recyclables. The collection services shall be available on the premises and shall be provided on a regularly scheduled basis of at least twice a month for collection of at least four broad types of designated recyclable materials. The collection schedule and recycling containers capacity shall provide for regular removal or the recyclables such that there is adequate storage capacity available in the recyclable containers to avoid overflowing containers. The owner and owner's employees may provide the collection services personally, or the owner may contract with a collector licensed by the City to provide the services.
- White Bear Lake. Refuse and recycling service multi-family, commercial and industrial
  sites: Every multi-family, commercial and industrial location in the City shall contract with a
  refuse and recycling contractor who will remove refuse and recyclable material at least once
  weekly.

#### **Recycling Container Placement**

*Findings:* Recycling containers should be placed next to trash containers when possible. At some of the larger multi-unit properties, the recycling container is located in a different area than the trash, in part due to a lack of space or a small enclosure. Referring back to the White Bear Royal Apartments example, the manager cited a lack of space as the reason for choosing recycling carts over a dumpster. However, expanding the concrete pad under the trash dumpster may provide the additional space needed for a recycling dumpster.

Recommendations for improvement: Managers may benefit from advice and assistance for optimizing the location of the trash and recycling. An added incentive could include a cost share grant used to help cover the added cost to expand concrete pads or enclosures.

#### **Recycling Labels**

*Findings:* Most recycling labels found on dumpsters and carts have an inconsistent color or message, have too much or too small text, or have too small illustrations. The labels are sometimes not placed in the proper location based on container orientation. Some are peeling, fading, or missing. For some multi-unit properties there are also language barriers to consider.

Recommendations for improvement: Partner cities and Ramsey County could collaborate to design a consistent label for use City-wide (or possibly County-wide) at all multi-units and commercial properties, possibly enforced in City hauler licenses and/or ordinances. The City or County could purchase the labels outright and giving them to haulers, or provide the hauler with an electronic template.

#### **Unwanted items**

*Findings:* Many multi-unit properties do not have a program in place to help tenants properly dispose of unwanted or bulky items such as furniture, batteries, fluorescent bulbs, electronics, and household hazardous waste. Others provide re-use tables, drop off containers for batteries and fluorescent lamps, and assistance with furniture disposal.

Recommendations for improvement: Some managers and tenants asked questions about how to dispose of certain items. These properties might benefit from educational materials explaining how to properly dispose of these items, and assistance with setting up a disposal program.

#### **Education**

*Findings:* Educational programs and materials are lacking at many of the multi-unit properties. Existing programs seem to be most successful if the manager, maintenance staff, or a resident are interested in recycling and have made a long term commitment to educate tenants, monitor the recycling containers, and promptly act on any issues. The challenge is maintaining a program for properties that experience high staff or tenant turnover.

Recommendations for improvement: Outside assistance with setting up an education program and providing long-term support may be beneficial for properties that do not have an educational program in place. Educational materials could be tailored to a specific building's problems (such as unwanted item disposal), physical structure (trash chute rooms), and methods of communication (bulletin boards, new tenant handbooks, etc.).

#### **Recycling service**

Findings and recommendations for improvement – Little Canada: Nine of the thirteen buildings at Montreal Courts, the largest multi-unit property in Little Canada, do not have recycling service. According to the property manager, the hauler discontinued recycling service to three apartment buildings and six townhome buildings located south of Labore Road due to excessive contamination found in the recycling dumpsters. This property may benefit from assistance in starting an educational program and reinstating recycling service.

The other ten properties with no recycling service in Little Canada are all 8 units and less: Antler (8 units), a four-plex on Park Street, and seven four-plexes and one duplex located on the east side of Ruth Street. The west side of Ruth Street consists of single family homes. An illustration of the Ruth Street multi-units was created for Little Canada (Exhibit 16). The property manager for Antler stated that recycling is cost prohibitive for smaller apartments and therefore wants to be included in the City recycling contract. When the project lead and County representative met with Little Canada, there was a discussion about the possibility of changing the multi-unit definition to greater than 9 units in order to include these smaller properties in the City recycling contract.

Findings and recommendations for improvement – White Bear Lake: There is no recycling service for four properties in White Bear Lake: Cedar Eight Apartments (8 units), apartment on 9<sup>th</sup> Street (12 units), East Metro Women's Council (34 units), and Pine View Apartments (72 units). As with Little Canada, White Bear Lake may want to consider revising their multi-unit definition to exclude 8 units and possibly 12 units so two of the properties currently without recycling can be included in the City's recycling contract. An employee at East Metro Women's Council mentioned that recycling was removed due to contamination but is interested in starting a recycling program again. This property may benefit from assistance in starting an educational program.

Objective 3: Develop a partnership among the cities involved to provide expanded recycling outreach

The project lead and County representative visited with each participating community to go over the results of this project. Each partner can use the results to tailor their own multi-unit recycling program, and share the results with their City Council, environmental commissions, and through their website, official City Facebook and Twitter accounts, newsletters, and other communication modes. A list of property contacts is provided in Exhibit 17.

The results of this project were also shared with the Ramsey County Recycling Coordinators Group, Anoka County Solid Waste Abatement Advisory Team, White Bear Lake Environmental Advisory Commission, and White Bear Lake City Council.

A Multi-Unit Recycling Project Managers group was recently formed, providing an opportunity to discuss project management and implementation and to share updates, lessons learned, new ideas, and best practices. The every-other-month meetings are open to all County, City, and private multi-unit recycling project managers in the Twin Cities area. The project lead will be actively involved in this group and will share results of this project.











## Typical Recycling Issues Observed at Large Multi-Unit Properties





**LABELS:** Recycle labels on dumpsters and carts are insufficient: inconsistent color or message, too much or too small text, no images or too small illustrations, not in proper location, peeling, fading, missing. Language barriers.

**DUMPSTER PLACEMENT:** inconvenient placement of recycling dumpsters/carts, recycling in a different location than trash.

**EDUCATION:** Limited educational programs at many buildings. Educate adults with children: tenants with families may have their kids bring out trash and recyclables.

**UNWANTED ITEMS**: No tenant programs in place for the disposal of unwanted items such as furniture, batteries, light bulbs, televisions, etc.

**LEVEL OF SERVICE:** Insufficient number of recycling carts, recycling not picked up often enough.
